FEEDING DIRECTIONS

This feed is designed to be fed to cattle along with high quality forage (hay or pasture) at a rate of 2.5 to 10 lbs. per head per day to provide not less than 50 nor more than 200 milligrams of monensin per head per day. Provide plenty of clean, fresh water at all times.

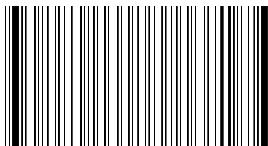
CAUTION: A withdrawal time has not been established for preruminating calves. Do not use in calves to be processed for veal. Do not allow horses or other equines access to formulation containing Monensin. Ingestion of Monensin by equines has been fatal. Monensin medicated cattle and goat feed is safe for use in cattle and goats only. Do not exceed the levels of Monensin recommended in the feeding directions as reduced average daily gains may result. If feed refusals containing Monensin are fed to other groups of cattle, the concentration of Monensin in the refusals and amount of refusals fed should be taken into consideration to prevent Monensin overdosing.
